## LIABILITY WAIVER, INCLUDING COVID-19 LIABILITY WAIVER

I further agree to indemnify and hold harmless YIH against all claims, suits, or actions of any kind whatsoever for liability, damages, compensation, or otherwise brought by me or anyone on my behalf, including attorney’s fees and any related costs, if litigation arises pursuant to any claims made by me or by anyone else acting on my behalf. If YIH incurs any of these types of expenses, I agree to reimburse YIH.
